At the Disciplinary Conference on July 28, 2011, I determined that you were responsible for violating the following rule(s) of the Code of Student Conduct:

### Harassment

Specifically, you admitted: to placing your hand on Adele Smith's knee, attempting to provoke her to slap you and or to kiss you to deal with her frustrations with you, and finally for telling some students around campus that she had seduced you. You did emphasize at length with regards to the first two incidents that they were not done maliciously and you found them to be normal interactions. As I informed you at the meeting, I do not find these interactions with Adele to be acceptable, appropriate, or in keeping with our Code of Student Conduct. Therefore I found you responsible for the violation of Harassment.

You were informed that I would be mandating your sanction, after receiving input from you during our Disciplinary Conference. The sanction I am mandating is **Housing Suspension for 1 year**. Furthermore, you will remain on **Disciplinary Probation until May 30, 2012**. A review will be conducted at the end of Spring 2012 semester to determine whether you should remain under probation for your final semester of Fall 2012.

Disciplinary Probation is period of review and observation during which a student has been officially notified by the College that his/her conduct was very inappropriate. Further violations of College rules, standards or policies (even after the expiration of a particular probationary period) could result in more severe sanctions.

Conditions of your sanction are as follows:

➤ **Restricted Campus Privileges for 1 semester:** You are restricted from being on campus except for the following: Mass, Class, predefined blocks to meet with faculty or use the library, some approved major campus events and the Chester Belloc Debate Society events. All other times you are restricted from being on campus. Approval must come through the Dean of Students and requests for exceptions beyond the above listed ones will only be granted on a limited basis.

➤ **No Contact with Adele Smith:** You must refrain from any contact with Adele Smith until further notice. This includes, but is not limited to, written and verbal contact, communication by telephone (including texting), e-mail, instant messaging, online communication and face-to-face contact on or off campus. This is not meant to be an exhaustive list, but instead to reaffirm the underlying intent to separate you from one another. Direct contact (or indirect contact such as messages sent through friends) may be deemed to be harassing in nature resulting in the filing of

Code of Student Conduct charges. Inclusion of other students in this matter may also lead to charges for disruption of their educational pursuits. It is understood that on our small campus it will be impossible to avoid some incidental contact or presence around similar friends, but communication should be avoided. Adele will be advised of this restriction and asked to respect it as well.

**Additionally, you may face additional charges under the Code of Student Conduct for failing to complete mandated sanctions. Lastly, you will not receive your diploma or transcripts until the successful completion of all sanctions.**
